## Key Activities of the Month:



On January 14, 2021, the Press Secretariat Unit at the Office of the Prime Minister held its monthly Addis Weg Round Table discussion on the development journey of highland and pastoralist communities. The 'Addis Weg' discussions are intended to cultivate a culture of dialogue. Bringing differences to the proverbial table and hall, 'Addis Weg' aims to narrow contestations through dialogue, nurture plurality of ideas, and encourage the development of innovative solutions to old and new challenges.

The January discussion explored the existing livelihood of pastoralists, the benefits and challenges of the policies implemented over the years, and the ongoing efforts to ensure sustainable development and benefit the community.

## Legislative/Policy Updates:

During its 94th regular meeting, the Council of Ministers discussed the draft proclamations on Ethiopian overseas employment, justice related cooperation agreements between Ethiopia and Uganda, visa waiver agreements between Ethiopia and South Africa, the fee for accounting and auditing board services, amendment of the Ethio Telecom Establishment Regulation, and the 5th round implementation of the developmental Safety Net Credit Agreement.

- The Overseas Employment Proclamation amendment is intended to address the gaps in the implementation of the previous proclamation.
- The agreement on legal cooperation between Ethiopia and Uganda aims to extradite wanted suspects and address criminal cases in a collaborative manner by creating a legal framework and facilitating justice towards cross-border and organized crimes.
- The agreement signed between Ethiopia and South Africa on visa-free travel for service and diplomatic passport holders not only strengthens historical and diplomatic ties, but also saves time consumed by completing visa and related procedures.
- Payment for accounting and audit board services is subject to government-mandated rates, and the proclamation that includes research-based billing system has been approved by the Council of Ministers.
- The revised Ethio Telecom Establishment Regulation that allows the institution to keep pace with the rapidly growing and dynamic nature of the sector and provide related additional services has also been approved for implementation.

The proclamation regarding the 5th round implementation of the Developmental Safety Net Program that allows \$200 million loan agreement with a 6-year relief and 38 years of installment has also been submitted to the House of Representatives for endorsement.
